ROLE OF THE GOVERNING BOARD

Creating robust accountability

- Accountability for teaching, achievement,
 behaviour and safety
- Strengthening and supporting school leadership
- Performance managing the headteacher
- Contributing to school self-evaluation.

Ensuring financial probity

- Making sure the school's money is well spent
- Monitoring the use of the pupil premium grant and other resources to overcome barriers to learning.

In previous years, the Governing Board held committee meetings in addition to Full Governing Board meetings. However, the number of meetings has reduced to 4 Full Governing Board meetings per year from September 2025. There is a business meeting at the start of the

Autumn Term to review link governor roles and schedule monitoring visits. The school budget is reviewed and approved by the governors at the meeting in April each year ready for the start of the financial year in May.

Governors have links to Pupil Premium, Health & Safety and SEND and visit school regularly to meet pupils and staff. In addition, they monitor aspects of the curriculum or areas such as attendance monitoring along with Safeguarding.
